CB-85-2006 – AN ACT CONCERNING THE CLASSIFICATION PLAN FOR PRINCE
GEORGE'S COUNTY for the purpose of amending the Classification Plan which, pursuant to
CB-44-2006, eliminated and added certain classes of work in accordance with the Public
Employee Relations Board (PERB) Representation Amendment of Certification, and established a new Y Salary Schedule. This act amends the Classification Plan by correcting the class code for two classes of employees. – *PRESENTED* 

Council Bill 85 was presented by the Chairman at the request of the County Executive and referred to the Committee of the Whole (COW).

#### (c) <u>Introduction of Resolutions</u>

**CR-80-2006** – **A RESOLUTION CONCERNING NEWTON GREEN APARTMENTS** for the purpose of providing the required approval to the Department of Housing and Community Development of the State of Maryland ("DHCD") for the financing of the acquisition and development of the Newton Green Apartments, a senior rental project to be owned and operated by Newton Green, LLC a joint venture of Ingerman Affordable Housing, Inc. (collectively referred to as the "Owner"). – **INTRODUCED**

<u>PRINCE GEORGE'S COUNTY</u> for the purpose of upgrading existing classes of work.

Council Member Peters, Chair, Public Safety and Fiscal Management (PSFM) Committee, provided a verbal report of the actions and recommendations of the Committee to the Council. Council Bill 40(DR-2) amends the Classification Plan by changing the grades of the Construction Standards Inspector and Engineer class series. Council Bill 40(DR-2) was favorably reported out of PSFM on October 11, 2006 with amendments. Council Bill 40(DR-2) was introduced by Council Members Peters, Dean, Dernoga, Bland and Exum.

<u>CB-80-2006 (DR-2) – AN ACT CONCERNING FIRE SAFETY CODE</u> for the purpose of amending several provisions of the Prince George's County Fire Code to conform to international fire safety standards, to increase administrative fees and civil fines, and generally relating to the Fire Safety Code – <u>INTRODUCED</u>

Council Member Peters, Chair, Public Safety and Fiscal Management (PSFM) Committee, provided a verbal report of the actions and recommendations of the Committee to the Council. Council Bill 80(DR-2) amends Subtitle 11, Fire Safety Code to adopt the latest version of the National Fire Protection Association (NFPA) Life Safety Code 101 and the Fire Prevention Code for the State of Maryland and to adopt local amendments to the County's Fire Safety Code Council Bill 80(DR-2) was favorably reported out of PSFM on October 11, 2006 with amendments. Council Bill 80(DR-2) was introduced by Council Members Bland, Dernoga, Dean and Peters.

<u>CB-81-2006 (DR-2) – AN ACT CONCERNING COMMERCIAL VEHICLES</u> for the purpose of amending provisions of the Code relating to parking regulations and amending the hours commercial vehicles may be parked on County streets or highways. – <u>INTRODUCED</u>

Hawi Sanu, Committee Director, of the Transportation, Housing and the Environment (THE) Committee provided a verbal report of the actions and recommendations of the Committee to the Council. Council Bill 81(DR-2) amends provisions of the Code relating to parking regulations and amending the hours commercial vehicles may be parked on County streets or highways. Council Bill 81(DR-2) was favorably reported out of THE on October 12,2006 with amendments. Council Bill 81(DR-2) was introduced by Council Members Knotts, Bland, Campos, Exum, Dernoga and Dean.
