BACKGROUND INFORMATION/FISCAL IMPACT:

This resolution amends the adopted FY 2026 Budget for the Prince George's County portion of the Maryland-National Capital Park and Planning Commission (M-NCPPC). The FY 2026 Operating and Capital Budgets for M-NCPPC were adopted on May 29, 2025, by way of CB-055-2025. Title 18 of the Land Use Article, Annotated Code of Maryland, authorizes the County Council to amend the adopted M-NCPPC budget by way of resolution following a public hearing. The proposed amendment is made to take advantage of opportunities identified after the budget was adopted.

The resolution amends the current year budget for the Administration Fund by reducing funding for the Planning Department by \$1 million to fund a new \$1 million project charge to the Office of the County Executive - Deputy Chief Administrative Officer for Economic Development. The project charge will be used to support economic development planning activities within the County.
