LEGISLATIVE HISTORY

Housing and Economic Development
Committee Report

Committee Vote: Favorable, as amended, 4-0 (In favor: Council Members

Fletcher, Bell, MacKinnon and Wineland)

The Committee Director indicated that this resolution amends the Ten Year Solid Waste Management Plan to reflect actions previously taken by the Council on two subjects:

- 1) The <u>Solid Waste Recycling Plan</u> (adopted by CR-58-1990), which is briefly described and incorporated by reference into the Solid Waste Management Plan; and
- 2) The F & E Resource Systems Technology (or FERST) proposal for a mixed solid waste handling facility on a site at 14800 Gibbons Church Road in Brandywine, which was the subject of CB-77-1990 and

CR-9-1991. (CB-77 is a zoning bill which made "waste material separation and processing facilities" a permitted use in the I-2 Zone. CR-9 related to Maryland Energy Financing Administration industrial development revenue bonds to assist FERST.)

Following discussion, it was decided that lines 23-27 on page 5 and line 1 on page 6 should be deleted from the body of the resolution and included instead in the preamble to CR-43 inasmuch as it is background information relating to a Memorandum of Agreement to which the County is not a party.

BACKGROUND INFORMATION/FISCAL IMPACT (Includes reason for proposal, as well as any unique statutory requirements)

This resolution will amend the Prince George's County FY1986-1995 Comprehensive Ten Year Solid Waste Management Plan to incorporate the Prince George's County Recycling Plan and add the F&E Resource Systems Technology of Prince George's Inc. (FERST) Mixed Waste Materials Separation and Processing Facility. The resolution approving the Prince George's County Recycling Plan was CR-58-1990.
