BACKGROUND INFORMATION/FISCAL IMPACT:

Prince George's County, Maryland and the Prince George's Correctional Officers' Association (Civilian Unit) have completed labor negotiations on a two-year labor agreement covering Fiscal Year 2025 and Fiscal Year 2026.
