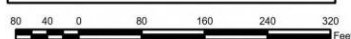
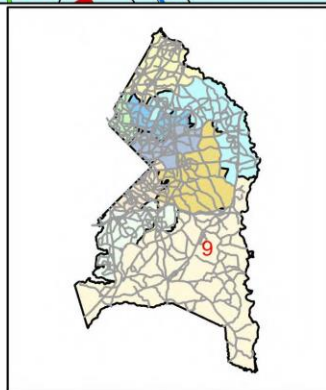
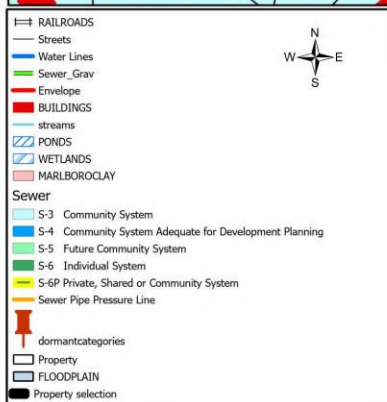
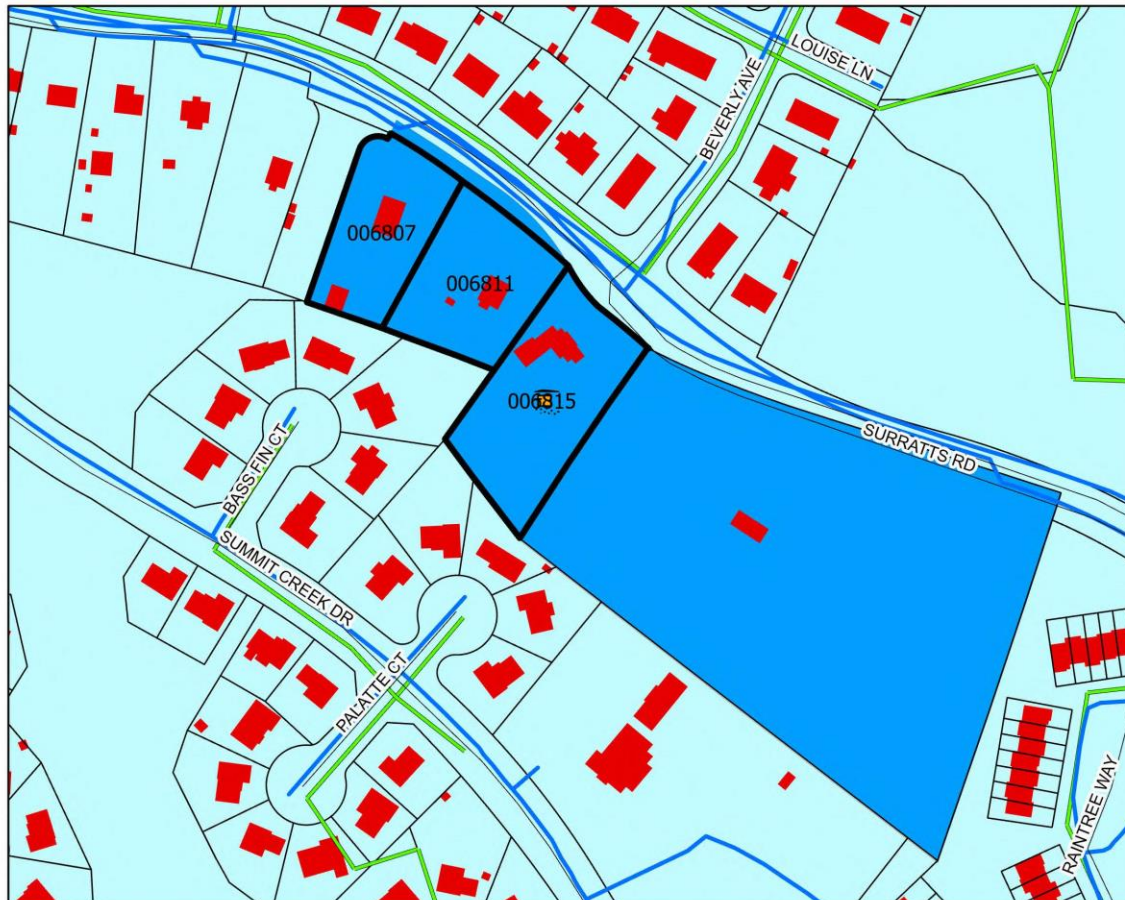


Surratts Road

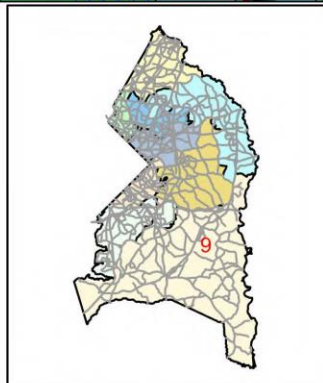
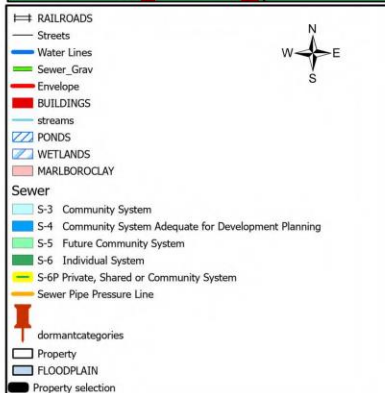


Accokeek Road W / Livingston Road

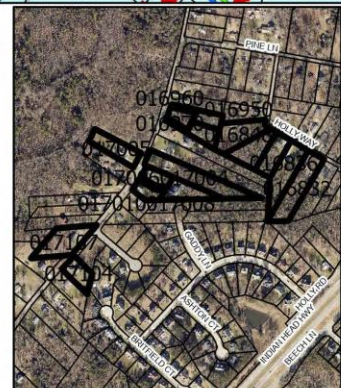
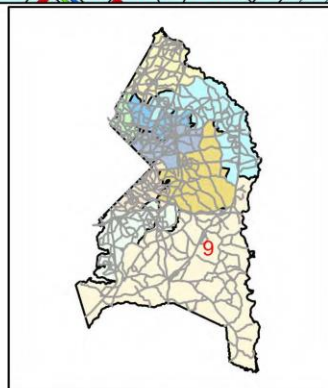


Livingston Road / Holly Way
