BACKGROUND INFORMATION/FISCAL IMPACT:

The purpose of this resolution is to repeal CR-82-2025 and terminate a major amendment to the 2007 *Approved Westphalia Sector Plan* and concurrent sectional map amendment. The period of time allotted to this plan amendment was not sufficient to carry out the necessary revision to the 2007 Sector Plan and was determined unnecessary to proceed with further analysis of the Westphalia Public Facilities Financing and Implementation Program created by CR-66-2010. Action is required January 27, 2026 as the final date for the Planning Board to release the Staff Draft Major Plan Amendment and proposed SMA to the public is January 29, 2026.
