**BILL**

1 AN ACT concerning

2 Borrowing to Finance Capital Projects for  
3 Public Works and Transportation Facilities

4 For the purpose of authorizing Prince George's County, Maryland, to borrow money upon its full  
5 faith and credit at any time and from time to time, in an aggregate principal amount not  
6 exceeding \$140,089,000 to finance the design, construction, reconstruction, extension,  
7 acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation, or repair  
8 of Public Works and Transportation Facilities, (including roads and bridges, parking lots, and  
9 maintenance facilities), including the acquisition and development of sites therefor, the  
10 architectural and engineering services incident thereto, and the acquisition and installation of  
11 necessary fixed permanent equipment therefor, prescribing terms and conditions upon which  
12 bonds issued pursuant to this Act shall be issued and sold and other incidental details with  
13 respect thereto; providing generally for the issuance of such bonds and providing for such  
14 borrowing to be submitted to a referendum of the legal voters of the County.

15 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
16 Maryland, that Prince George's County, Maryland (the "County"), is hereby authorized, pursuant  
17 to Section 323 of the Charter of Prince George's County, Maryland (the "Charter"), to borrow  
18 money and incur indebtedness upon its full faith and credit, at any time and from time to time, in  
19 an aggregate principal amount not exceeding \$140,089,000 to finance the design, construction,  
20 reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation,  
21 relocation, rehabilitation, or repair of, Public Works and Transportation Facilities (including

1 roads and bridges, parking lots, and maintenance facilities), including the acquisition and  
2 development of sites therefor, the architectural and engineering services incident thereto, and the  
3 acquisition and installation of necessary fixed permanent equipment therefor, all such capital  
4 projects hereby being found to be (and also being in fact) of the same generic class and being  
5 described in the capital program of the County for the fiscal years 2027-2032, under the  
6 following headings, which descriptions are incorporated by reference as if set forth herein:

26 Reference to the County's capital program for the fiscal years 2027-2032 is made for  
27 purposes of description only and such reference shall include the same capital projects in any  
28 amended or subsequent capital program.

29 SECTION 2. BE IT FURTHER ENACTED that any general obligation bonds to be issued  
30 pursuant to this Act shall be issued and sold pursuant to Bond Issue Authorization Ordinances  
31 adopted in accordance with Sections 323 and 823 of the Charter and other applicable provisions

1 of MD. CODE ANN., LOCAL GOV'T. §§ 19-205 to 19-206, as amended, replaced, or re-  
 2 codified from time to time, but the County shall sell such bonds only by solicitation of  
 3 competitive bids therefor at public sale in such manner and after giving such public notice as the  
 4 County Council may by ordinance determine. Such bonds may be sold for such price or prices  
 5 as may be determined to be for the best interest of the County, either at, above or below the par  
 6 value of any such bonds, and such bonds may be sold in conjunction with other series of bonds  
 7 issued by the County in which event the notice of sale soliciting bids for the purchase of such  
 8 bonds may require that the acceptance of any bid for any series of bonds be made contingent  
 9 upon the acceptance of the bid or bids on all or any of the series being offered by the County for  
 10 sale at the same time. When such bonds are sold in conjunction with other series of bonds, the  
 11 said notice of sale may also require that consolidated bids shall be submitted on any two or more  
 12 of such series of bonds.

13 Nothing in this Act shall in any way limit the authority provided for the refunding of  
 14 County indebtedness by MD. CODE ANN., LOCAL GOV'T. §§ 19-205 to 19-206, as amended  
 15 or supplemented from time to time or by any other applicable law, and all such authority is  
 16 intended to be available to the County to refund any indebtedness incurred pursuant to this Act to  
 17 the maximum extent provided by such authority.

18 Such bonds may be issued in an amount sufficient to finance the costs of the Public Works  
 19 and Transportation Facilities and the cost of issuance of the bonds. Prior to the application of the  
 20 proceeds of such bonds to finance the costs of the Public Works and Transportation Facilities,  
 21 the cost of issuance of such bonds for such Public Works and Transportation Facilities may be  
 22 deducted from such proceeds.

23 SECTION 3. BE IT FURTHER ENACTED that this Act shall be submitted to the legal  
 24 voters of the County, for their approval or disapproval, at the general election to be held in the  
 25 County on Tuesday, November 3, 2026. The question to be certified to the Board of Supervisors  
 26 of Elections of the County for inclusion on the ballot for said general election shall be in  
 27 substantially the following form:

28 **PUBLIC WORKS AND TRANSPORTATION FACILITIES BONDS**

29 This measure will authorize the County to borrow money by issuing bonds of up to  
 30 \$140,089.000 to pay for roads, bridges, parking lots, and maintenance facilities.

31 FOR: A vote “for” this measure will allow the County borrow money by issuing bonds to

1 pay for roads, bridges, parking lots, and maintenance facilities.

2 AGAINST: A vote “against” this measure will prevent the County from borrowing money  
3 by issuing bonds to pay for roads, bridges, parking lots, and maintenance facilities.

4 SECTION 4. BE IT FURTHER ENACTED that the powers granted by this Act are  
5 additional and cumulative and the bonds to be issued pursuant to this Act may be issued,  
6 notwithstanding that other bond acts or laws may provide for the issuance of other bonds or the  
7 borrowing of money for the same or similar purposes on the same or other terms and conditions.  
8 This Act shall be liberally construed to effectuate its purposes, namely, to authorize the  
9 borrowing of money and the incurring of indebtedness to finance the described capital projects of  
10 the same generic class set forth in this Act. Provisions of this Act shall be deemed met and  
11 satisfied if there is substantial compliance with such provisions, including (without limitation)  
12 provisions relating to the submission of any question to the legal voters of the County which are  
13 intended only to provide fair and adequate notice to such voters and not to prescribe provisions  
14 which must be literally satisfied. This Act is not intended to provide or imply that this act or any  
15 prior act not containing a similar provision precludes the County from exercising any power or  
16 prerogative provided by this Act or any other law whether exercised solely pursuant to such  
17 other law or in conjunction with the powers provided by this Act so that, without limiting the  
18 generality of this section, the County may exercise the power to issue (i) bond anticipation notes  
19 (in anticipation of the issuance of bonds pursuant to this Act or otherwise) and grant anticipation  
20 notes pursuant to MD. CODE ANN., LOCAL GOV’T. [§§ 19-205 to 19-206,] §19-212, as  
21 amended, replaced, or re-codified from time to time, and (ii) bonds (or any related bond  
22 anticipation or other notes) authorized by MD. CODE ANN., LOCAL GOV’T. §§ 19-205, [to]  
23 19-206, and §19-212, as amended, replaced, or re-codified from time to time, and in exercising  
24 such powers, the County may sell such notes or bonds at private (negotiated) sale as authorized  
25 by these or any other applicable laws.

26 SECTION 5. BE IT FURTHER ENACTED that the provisions of this Act are hereby  
27 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,  
28 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of  
29 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining  
30 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this  
31 Act, since the same would have been enacted without the incorporation in this Act of any such

1 | invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,  
2 | or section.

3 | SECTION 6. BE IT FURTHER ENACTED that this Act shall become effective  
4 | immediately upon the date of the official certification of its approval by the voters at said general  
5 | election.
