WHEREAS, the Chart	er of Prince George's County, Maryland provides for the adoption of					
the County budget, including	g the capital program; and					
WHEREAS, the capita	al program sets forth the plan of proposed capital projects to be					
undertaken in the ensuing fiscal year and in each of the next five fiscal years, and also the						
proposed means of financin	g said projects; and					
WHEREAS, pursuant to the provisions of Section 818 of the Charter for Prince George's						
County, Maryland the County Council may authorize, by legislative act, upon request of the						
County Executive, transfers	of appropriations between capital projects in the Approved Capital					
Budget; and						
WHEREAS, under the	e provisions of Section 824 of the Charter for Prince George's County,					
Maryland, the County Council, may, upon receipt of a recommendation in writing from the						
County Executive, after pub	olic hearing and with the affirmative vote of two-thirds of its					
members, amend the Capita	al Budget in accordance with such recommendations, without					
increasing the total amount of appropriations therefore; and						
WHEREAS, the Coun	ty Executive deems it desirable to provide additional appropriations					
in the Capital Budget for the Detention Center Expansion (JT561273); and						

1	WHEREAS, th	e County Execu	utive recommends that	appropriations	can be transferred from	
2	the Contingency Fund, as an excess of appropriations over estimated costs in the budget year
