## PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 2/12/03

Committee Vote: Favorable, 4-0, (In favor: Councilmembers Exum, Bland, Hendershot and Peters.)

This bill will amend sections of the County Code to conform with the amendments to the County Charter approved by the voters in the 2002 General Election.

The following amendments were:

- 1. On page 1, lines 24-25, the governmental immunity level is reduced from \$250,000 to \$200,000.
- 2. On page 2, line 27, the community college is deleted from the liability level since it is governed by Local Government Tort claims rather than the Education Article.
- 3. On pages 3–9, the amendment concerns the jurisdiction of the Personnel Board over non-employee appeals. The right of non-employees to appeal is deleted on the following:

Page 4, lines 23-24

Page 5, lines 11-12, 25-26

Page 6, lines 2,4,8,13

Page 7, line 31

Page 8, lines 1, 10-11

Page 9, lines 6-7, 11-12

The Office of Law has reviewed the legislation and it to be in proper legislative form with no legal impediments to its enactment.

There should not be any negative fiscal impact on the County as a result of enacting CB-5-2003.

## BACKGROUND INFORMATION/FISCAL IMPACT

(Includes reason for proposal, as well as any unique statutory requirements)

At the 2002 General Election, the voters ratified four sets of amendments to the County Charter. The proposed legislation amends various sections of the County Code to conform to specific amendments approved by the voters. Specifically, the limitations of liability are amended in Section 10-174 and the appeal rights of applicants for County employment are deleted in Sections 16-105, 16-160, 16-164, and 16-202.
