## **EXPLANATION OF ADJUSTMENTS**

### **CIRCUIT COURT**

The Administrative Office of the Courts, Mediation and Conflict Resolution Office (MACRO) awarded \$95,021 for the Mediation and Conflict Resolution (MACRO) grant. Funding supports the court's civil, non-family Alternative Dispute Resolution (ADR) services to better serve the court users of Prince George's County. An appropriation in the amount of \$3,233 is required to expend the award.

### **OFFICE OF THE STATE'S ATTORNEY**

The State of Maryland Governor's Office of Crime Prevention and Policy awarded \$100,000 for the Judicial Dialogue Enhancement grant. Funding will support the Judicial Dialogue System (JDS)/Legal Edge Software that will store case information and the creation of a digital dashboard.

The Maryland Department of Juvenile Services awarded \$100,000 for the Saturday Family Justice Academy grant. Funding will be used to reduce juvenile offences by reducing juvenile truancy. The program will provide guidance and support to assist youth and their families with issues that impact attendance.

The State of Maryland Governor's Office of Crime Prevention and Policy awarded \$116,561 for the Special Assistant United States Attorney (SAUS) grant. Program funding will be used to assist the office with investigations and prosecutions of the County's most dangerous violent and repeat offenders. An appropriation in the amount of \$8,561 is required to expend the award.

### **FIRE/EMS DEPARTMENT**

The Maryland Institute for Emergency Medical awarded \$26,000 for the MIEMSS Training Reimbursement/Advanced Life Support (ALS) grant. Funding will support advanced life education training programs offered to emergency medical services clinicians. Additional appropriation authority in the amount of \$16,000 is required to expend the award.

The Maryland Department of Natural Resources Chesapeake and Coastal Service Waterway Improvement Fund, Water Safety Rescue and Resource Enhancement grant requires a cash match. Funding will support the purchase of an inflatable non-motorized self-bailing raft. Additional appropriation authority in the amount of \$15,000 is required to expend the award.

The U. S. Department of Homeland Security Federal Emergency Management Agency, through the Government of the District of Columbia Homeland Security and Emergency Management Agency awarded \$105,000 for the Urban Areas Security Initiative (UASI) – Emergency Medical Services (EMS) Mobile Clinical Competency project. Funding supports equipment, technology, software and training gaps for the response to active violent incidents. The project provides resources to complete a mobile platform, contain scalable fire EMS learning components and is a local inter-governmental regional resource. Additional appropriation authority in the amount of \$5,000 is required to expend the award.

#### **OFFICE OF HOMELAND SECURITY**

The District of Columbia Homeland Security and Emergency Management Agency awarded \$158,000 for the Homeland Security Grant Program, Urban Areas Security Initiative, Hazardous Weather Preparedness. Funding supports flood warning equipment and weather stations.

#### **DEPARTMENT OF FAMILY SERVICES**

The Maryland Department of Aging awarded \$74,729 for the State Guardianship program. Funding provides funding for case management services for individuals referred by the courts and for whom the Department's Director has been appointed legal guardian. Additional appropriation authority in the amount of \$5,500 is required to fully expend fee collections the Department anticipates receiving.

The Maryland Department of Aging awarded \$56,356 for the State Hold Harmless program. Funding ensures that compensatory education aid does not decline year-over-year as a result of the enrollment declines from the COVID-19 pandemic.

The Maryland Department of Aging, Federal Older Americans Act Award awarded \$2,627,103 for the FY24 Title VII Ombudsman, Title IIIC1 Congregate Meals, Title IIIC2 Home Delivered Meals and Title IIIE Caregivers programs. Funding provides support for resources to promote health awareness and wellness among older Americans. Additional appropriation authority in the amount of \$17,816 is needed to fully expend the award received.

The Maryland Department of Aging, Federal Older Americans Act Award awarded \$49,139 for the Title IIIB: Ombudsman program. Funding provides support for the residents of nursing homes and assisted living facilities. Additional appropriation authority in the amount of \$36,039 is needed to fully expend the award received.

The Maryland Department of Aging, Federal Older Americans Act awarded \$455,380 for the Title IIIE Caregiver program. Funding provides support for services to caregivers through existing programs. Additional appropriation authority in the amount of \$55,080 is needed to fully expend the award received.

The Maryland Department of Aging awarded \$38,661 for the Medicare Improvement for Patients and Providers Act (MIPPA). Funding provides support for the promotion of low-income services for Medicare beneficiaries. Additional appropriation authority in the amount of \$24,161 is needed to fully expend the award received.

The U.S. Department of Health and Human Services, through the Maryland Department of Aging award \$54,913 for the Title III-D Senior Health Promotion program. Funding provides support for promotion of health awareness and wellness for elderly County residents. Additional appropriation authority in the amount of \$9,613 is needed to fully expend the award received.

The U.S. Department of Health and Human Services, through the Maryland Department of Aging award \$41,107 for the Title VII Ombudsman program. Funding provides support for services to advocate for residents of nursing homes and assisted living facilities. Additional appropriation authority in the amount of \$7,007 is needed to fully expend the award received.

The U.S. Department of Health and Human Services, through the Maryland Department of Aging award \$1,317,877 for the Title IIIC-2: Nutrition for the Elderly Congregate Meals program. Funding provides support for services for nutrition programs for elderly County residents. Additional appropriation authority in the amount of \$240,378 is needed to fully expend the award received.

The U.S. Department of Health and Human Services, through the Maryland Department of Aging award \$895,342 for the Title IIIC-2: Nutrition for the Elderly Home Delivered Meals program. Funding provides support for services for nutrition programs for elderly County residents. Additional appropriation authority in the amount of \$285,342 is needed to fully expend the award received.

## **HEALTH DEPARTMENT**

The Department of Health and Human Services, Substance Abuse and Mental Health Services Administration awarded \$409,748 for the Adult Reentry Program. Funding will support successful outcomes for returning citizens who have substance use disorder and mental health disorders. Additional appropriation authority in the amount of \$9,748 is needed to fully expend the award received.

The Maryland Department of Health awarded \$763,586 for the Continuum of Care program. Funding will promote community-wide planning, improve coordination of resources and optimize self-sufficiency among those experiencing homelessness. Additional appropriation authority in the amount of \$19,186 is needed to fully expend the award received.

The Maryland Department of Health awarded \$1,225,834 for the Administrative Care Coordination Grant - Expansion. Funding will support Health Choice members with accessing their Health Choice benefits needs. Additional appropriation authority in the amount of \$43,534 is needed to fully expend the award received.

## **DEPARTMENT OF SOCIAL SERVICES**

The U.S. Department of Housing and Urban Development awarded \$400,000 for the Food Stamp

Employment and Training/Able Bodied Adults Without Dependent Supplemental Nutrition Assistance Program (FSET/ABAWD/SNAP). Funding supports costs related to assisting food stamp recipients in attaining long-term self-sufficiency through suitable employment. An additional appropriation of \$233,600 is required to fully expend the award.

The U.S. Department of Housing and Urban Development \$560,341 awarded for the Youth Homeless Demonstration Program. Funding supports the development and implementation of a community approach aimed at ending youth homelessness for households where no member is older than 24. An additional appropriation of \$156,941 is required to fully expend the award.

The U.S. Department of Health and Human Services, through the Maryland Health Benefit Exchange awarded \$2,034,500 for the Affordable Care Act-Connector Program. Funding provides assistance to consumers to educate about, apply for and enroll in appropriate health insurance products for the Capital Region. An additional appropriation of \$334,500 is required to fully expend the award.

#### **DEPARTMENT OF PUBLIC WORKS AND TRANSPORTATION**

The Department of Public Works and Transportation was awarded \$347,400 for the Statewide Special Transportation Assistance Program (SSTAP) grant to support the replacement of aging paratransit vehicles. Additional appropriation totaling \$14,500 is required to fully expend the award.

#### **DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**

The U.S. Department of Housing and Urban Development awarded \$7,603,462 for FY22 HOME American Rescue Plan. Funding supports housing services and shelter to individuals experiencing homelessness. Additional appropriation authority totaling \$11,377 is required to fully expend the award.

#### **NON-DEPARTMENTAL**

The County is awarded \$2,000,000 for the former hospital site in Cheverly from the Strategic Demolition Fund of the Maryland Department of Housing and Community Development.



Funding supports the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement and capital equipping of the demolition of the former Cheverly Hospital for redevelopment to create a mixed-use community. This award will be managed by the Redevelopment Authority.

The County is awarded \$2,000,000 for the former hospital site in Cheverly from the National Capital Strategic Economic Development Program of the Maryland Department of Housing and Community Development. Funding supports the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement and capital equipping of the demolition of the former Cheverly Hospital for redevelopment to create a mixed-use community. This award will be managed by the Redevelopment Authority.
