approves the petition of Arthur and Roswitha Leitch to establish an agricultural district.		
WHEREAS, a district agreement, dated on July 27, 2007, by Arthur and Roswitha Leitch		
requested the establishment of an agricultural preservation district for approximately 64.83 acres		
of land (Tax Map 174/Grid F1/Parcel 35/Tax Account 08-0832147 and 08-0832154) located at		
17220 Aquasco Farm Road in the Aquasco area in Prince George's County, Maryland, as		
generally shown on	the attached location map; and	
WHEREAS, the petition was referred to the Prince George's County Agricultural		
Preservation Advisory Board for review and recommendation; and		
WHEREAS, the Prince George's County Agricultural Preservation Advisory Board found		
that the Arthur and Roswitha Leitch property met the qualifying criteria for productivity, size		
and location as set by the Maryland Agricultural Land Preservation Foundation, and		
recommended establishment of the agricultural district on August 29, 2007; and		

WHEREAS, the Prince George's County Planning Board found that the establishment of the proposed agricultural district is compatible with existing and approved county plans and recommended approval of the petition and establishment of the district on October 23, 2007; and

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the land indentified as Tax Map 174/Grid F4Parcel 35/Tax Account 08-0832147 and 08-0832154described in the agricultural district petition filed by Arthur and
