**BACKGROUND INFORMATION/FISCAL IMPACT:**

Section 22-114 of the Public Utilities Article of the Annotated Code of Maryland requires that the sale refunding bonds by the Washington Suburban Sanitary Commission (“Commission”) shall be approved the County Executive and County Council of Prince George’s and Montgomery Counties, respectively. This approval must occur within 30 days of receipt of a Refunding Plan from the Commission. If action not taken within the thirty-day period, the Refunding Plan stands approved.
