Staff provided a summary of the resolution and referral comments that were received. CR-68-2012 concerns the State of Maryland Neighborhood and Community Assistance Program for the purpose of expressing approval of the project submitted by the Hospice of the Chesapeake, Inc. for the "Cheaspeake Kids Program" to the Maryland Department of Housing and Community Development for participation in the Department's Community Investment Tax Credit Program.

Kerry Watson, Council Liaison, Office of the County Executive, provided testimony in support of the resolution.

The Office of Law determined that CR-68-2012 was in proper legislative form and without legal impediments to its adoption.

The Office of Audits and Investigation indicated there will be no adverse fiscal impact on the County as a result of adopting CR-68-2012.

**BACKGROUND INFORMATION/FISCAL IMPACT:**

Hospice of the Chesapeake, Inc., a nonprofit organization based in Anne Arundel and Prince George’s Counties, is applying to the Maryland Department of Housing and Community Development for approval of the “Chesapeake Kids Program” project for participation in the Community Investment Tax Credit Program. Hospice of the Chesapeake, Inc. is seeking tax credit allocations in the amount of \$45,000.00 to support its efforts to provide support for families who are facing perinatal, infant and child loss and children who have experienced the loss of a parent or sibling. The State of Maryland requires local legislative support for participation in the Program.
