**BILL**

1 AN ACT concerning

2 The Prince George's County Code (2023 Edition)

3 For the purpose of adopting and publishing the 2023 Edition of the Prince George's County  
4 Code.

5 BY compiling, codifying, adopting and publishing:

6 The Prince George's County Code  
7 (2023 Edition).

8 WHEREAS, Article III, Section 321 of the Charter for Prince George's County provides  
9 that the County Council shall compile, codify, adopt, and publish a Code of laws of the County  
10 in effect at such times at intervals not greater than four years; and

11 WHEREAS, the County Code was last published as the 2019 Edition; and

12 WHEREAS, it is informative to the citizens of the County to append to the County Code  
13 the provisions of the County Charter and Laws relating to the Washington Suburban Transit  
14 District; now, therefore,

15 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
16 Maryland, that the Prince George's County Code, 2023 Edition, be and the same is hereby  
17 compiled, codified, adopted, and published:

18 (a) On and after the effective date of this Act, the Prince George's County Code, 2023  
19 Edition, consisting of Subtitles 1 through 23, Subtitles 24A through 26A, and Subtitles 28  
20 through 33, together with any additional Subtitles which may hereafter be enacted and any  
21 current Supplement to the County Code which may be issued, shall be, with respect to the matter

1 set forth therein:

2 (1) Conclusive evidence of the text of the Prince George’s County Code and all  
3 enactments dated on or before November 30, 2023.

4 (2) Prima facie evidence of:

5 (A) The Prince George’s County Charter, together with all amendments, and the  
6 Schedule of Legislation accompanying the Charter.

7 (B) Article 17 of the Public Local Laws of Maryland as enacted by the General  
8 Assembly of Maryland.

9 (C) All other County acts, ordinances, Code provisions, resolutions having the  
10 force of law, and all other legislation enacted or adopted after November 30, 2023.

11 (b) Supplements to the Prince George’s County Code, 2023 Edition, shall be published  
12 annually.

13 (c) The words “County Code” or “Code” shall be taken to mean the Prince George’s  
14 County Code, 2023 Edition, together with any current Supplement, unless the content clearly  
15 requires otherwise.

16 (d) The 2023 Edition of the Code supersedes previous editions thereof.

17 SECTION 2. BE IT FURTHER ENACTED that the 2023 Edition of the Prince George’s  
18 County Code shall take effect on the effective date of this Act. The master copy of the 2023  
19 Edition of the Code shall be authenticated by the Council’s Legislative Officers and delivered as  
20 a public record to the Clerk of the Council. The Clerk shall maintain the master copy together  
21 with any Supplements thereto. A copy of the 2023 Edition of the Code shall be available at the  
22 Office of the Clerk of the Council for public use during regular business hours.

23 SECTION 3. BE IT FURTHER ENACTED that the Council’s Legislative Officers are  
24 authorized to make appropriate editorial amendments and corrections to sections contained in  
25 Subtitle 4. Building to remove conflicts between references to the Building Code of the County.

26 SECTION 4. BE IT FURTHER ENACTED that the general penalty provided in Section  
27 1-123 of the County Code shall apply to every offense or violation made unlawful by the County  
28 Code unless a specific penalty therefor is otherwise provided by law.

29 SECTION 5. BE IT FURTHER ENACTED that this Act shall take effect on forty-five (45)  
30 calendar days after it becomes law.
