This joint public hearing convened at 6:05 p.m. with eight Council Members present along with Peter Shapiro, Chair, William M. Doerner, Member, and Manuel Geraldo, Member, Prince George's County Planning Board, Maryland-National Capital Park and Planning Commission. Tom Gross, Planning Supervisor, Historic preservation Section, provided a brief overview and introduced Kacy Rohn, Planner III, Historic Preservation, M-NCPPC, and Daniel Tana, Planner III, Historic Preservation, M-NCPPC, who facilitated a PowerPoint presentation titled "Evaluation for Historic Site Designation Mount Hermon Masonic Temple 4207 Gallatin Street, Hyattsville (Documented Property 68-010-95)." Mr. Tana's portion of the presentation highlighted the following: Evaluation for Historic Site Designation: Mount Hermon Masonic Temple; 4207 Gallatin Street; North elevation, May 11, 2024; Northwest corner, May 2024; East elevation, May 2024; Partial view of west elevation, May 2024; South elevation, July

2024; Detail views of front entrance (left) and northeast front window, May 2024; Detail of Hyattsville with subject property highlighted, Wm. Baist's map of the vicinity of Washington D.C., 1904; Wine and Johnson's Second Addition to Hyattsville (with subject property highlighted); Mount Hermon Masonic Temple, shown in its original form with a small gable-roofed entryway; Mount Hermon Lodge members conduct the cornerstone ceremony for the first Hyattsville municipal building in 1912; Detail of Mount Hermon Masonic Temple, Sanborn Fire Insurance Map from Hyattsville; Detail of Mount Hermon Masonic Temple, Sanborn Fire Insurance Map from Hvattsville; Conclusion and Recommendation.
