**RESOLUTION**

1 A RESOLUTION concerning

2 Fiscal Year (“FY”) 2023 Annual Action Plan for Housing and Community Development  
 3 For the purpose of approving and adopting the Prince George’s County Fiscal Year (“FY”) 2023  
 4 Annual Action Plan for Housing and Community Development (“FY 2023 Annual Action  
 5 Plan”).

6 WHEREAS, under the terms of the Housing and Community Development Act of 1974, as  
 7 amended, Prince George’s County is qualified as an urban county eligible to receive its forty-  
 8 eight year of entitlement for Community Development Block Grant (“CDBG”) Program funds in  
 9 the estimated amount of five million, two hundred six thousand, five hundred sixteen dollars  
 10 (\$5,206,526) and four hundred seventy thousand, thirty-seven dollars (\$470,037) in CDBG  
 11 Program Income for FY 2023; and

12 WHEREAS, under the terms of the Cranston-Gonzalez National Affordable Housing Act of  
 13 1990, as amended, Prince George’s County is qualified to receive its thirty-first year of  
 14 entitlement HOME Investment Partnerships (“HOME”) Program funds in the estimated amount  
 15 of two million, ninety four thousand, seven hundred fifty-six dollars (\$2,094,756) and one  
 16 million, four hundred eight thousand, four hundred eleven dollars (\$1,408,411) in HOME  
 17 Program Income for FY 2023; and

18 WHEREAS, under the terms of the McKinney-Vento Homelessness Assistance Act of  
 19 1987, as amended, Prince George’s County is qualified to receive its thirty-fifth year of  
 20 entitlement for Emergency Solutions Grants (“ESG”) Program funds in the estimated amount of  
 21 four hundred forty thousand, two hundred seventy-six dollars (\$440,276) and must provide an

1 estimated four hundred forty thousand, two hundred seventy-six dollars (\$440,276) in matching  
2 funds for FY 2023; and

3 WHEREAS, the FY 2023 Annual Action Plan is based on the U.S. Department of Housing  
4 and Urban Development (“HUD”) Federal Fiscal Year 2021 (County FY 2022) formula  
5 allocations with estimated entitlement allocations for each activity that may be proportionally  
6 adjusted to match the actual funding allocations, upon notification from HUD; and

7 WHEREAS, the U.S. Department of Housing and Urban Development (“HUD”) requires  
8 jurisdictions that receive assistance under certain community planning and development  
9 programs to submit a five-year consolidated plan and an annual action plan to the Secretary of  
10 HUD that outlines ways to develop viable communities by: providing decent housing, a suitable  
11 living environment, and expanding economic opportunities principally for low- and moderate-  
12 income persons; and

13 WHEREAS, the Consolidated Plan, adopted by CR-047-2020, was prepared following a  
14 detailed citizen participation plan and identified and assessed housing and community  
15 development needs, incorporated a housing market analysis, and presented a strategic plan for  
16 addressing priority needs; and

17 WHEREAS, pursuant to Subtitle 15A of the Prince George’s County Code, the County  
18 Executive transmitted the FY 2023 Annual Action Plan, incorporating the grant applications, and  
19 the County Council duly advertised and conducted a public hearing on the FY 2023 Annual  
20 Action Plan; and

21 WHEREAS, the County Council, in recognition of the public testimony and on the basis of  
22 its review and analysis of the FY 2023 Annual Action Plan, finds that the FY 2023 Annual  
23 Action Plan generally conforms to the provisions and intent of Subtitle 15A of the Prince  
24 George’s County Code.

25 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
26 County, Maryland, that the Fiscal Year (“FY”) 2023 Annual Action Plan for Housing and  
27 Community Development, a copy of which shall be marked for identification by the Clerk of the  
28 County Council and maintained as a permanent record, is hereby approved, in accordance with  
29 the activities described in the FY 2023 Funding Recommendations Summaries and the FY 2023  
30 Annual Action Plan, Attachments “A” and “B”, respectively, as attached hereto and made a part  
31 hereof.

1 BE IT FURTHER RESOLVED that the County Executive or her designee is hereby  
2 authorized and empowered as the official representative of Prince George’s County to submit the  
3 approved FY 2023 Annual Action Plan to U.S. Department of Housing and Urban Development  
4 (“HUD”), along with all assurances contained therein, to act as necessary in connection with the  
5 submission, and to provide such additional information to HUD as may be required.
