**AN EMERGENCY ACT CONCERNING TEMPORARY RENT**

**STABILIZATION ACT OF 2023** for the purpose of extending the sunset date of the Temporary Rent Stabilization Act of 2023 for a period of six (6) months from April 17, 2024 to October 17, 2024 to continue combating the existing public emergency affecting the public health, safety, and welfare; said emergency being the threat of homelessness due to a lack of affordable housing.
