Committee of the Whole Vote: Favorable with amendment, 8-0 (In favor: Council Members Campos, Davis, Harrison, Lehman, Olson, Patterson, Toles and Turner /Absent: Franklin).

Staff provided a referral comments that were received. CR-117-2013 approves amending the Annual Action Plan for Housing and Community Development: FY 2013 and approving the reprogramming and restructuring of \$2,558,911.43 in Community Development Block Grant ("CDBG") funds from the FY 2005, FY 2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011, FY 2012 and FY 2013 Annual Action Plans to activities related to housing and community development.

DHCD Director Eric Brown provided a testimony in support of a Proposed Draft 2 of CR-117-2013, with would reduce the amount of reprogramming and restructuring to \$1,903,813 (a reduction of \$685,014.83 in funds) and Director Brown answered questions by the members of the Committee, particularly related to the change in allocations to groups and the notification process for awarded grants. The revised allocations in Attachments A, B & C are reflected in Draft 2 of CR-117-2013.

According to the Office of Audits and Investigations adopting CR-117-2013 will not have an adverse fiscal impact on Prince George's County as it reallocates existing federal funding.

The Office of Law finds CR-117-2013 to be in proper legislative form with no legal impediments to its enactment.

This resolution will amend the Annual Action Plan for Housing and Community Development: FY 2013 and approve the reprogramming and restructuring of \$1,903,813 in CDBG funds from FY 2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011, FY 2012, and FY 2013 Annual Action Plans to activities related to housing and community development. This resolution requires a minimum of one public hearing under the "County Citizen Participation Plan: FY 2011-2015" because it changes the use of CDBG funds from one activity to another and changes the purposes of activities.
