RESOLUTION

1 A RESOLUTION concerning

2 Live Near Your Work Program

3 For the purpose of approving an expanded Live Near Your Work Program Boundary in
4 cooperation with the Department of Housing and Community Development of the State of
5 Maryland (“the Department”) and authorizing the Redevelopment Authority of Prince George’s
6 County to operate the Live Near Your Work Program.

7 WHEREAS, Article 83B, Sections 2-201 through 2-208 of the Maryland Annotated Code
8 established the Live Near Your Work Program, which is a cooperative effort between the State
9 of Maryland, local jurisdictions and employers to provide financial assistance to eligible
10 employees in purchasing homes near their place of employment; and

11 WHEREAS, Prince George’s County approved a Live Near Your Work Grant Program in
12 cooperation with local employers and the Department pursuant to CR-71-1998; and

13 WHEREAS, the Live Near Your Work Program requires the local government to designate
14 a Live Near Your Work Boundary describing the area (or areas) within the jurisdiction’s
15 “designated neighborhoods” where Live Near Your Work Areas may be located; and

16 WHEREAS, Prince George’s County previously approved a Live Near Your Work
17 Boundary as shown in CR-71-1998; and

18 WHEREAS, the County Council of Prince George’s County, Maryland designated Walker
19 Mill revitalization area, attached hereto and incorporated by reference herein as Attachment “A”,
20 as a “designated neighborhood” in CR-47-2000, and it is the intent of the governing body of
21 Prince George’s County to include said Walker Mill revitalization area within the County’s Live
22 Near Your Work Boundary; and

1 WHEREAS, the City Council of Glendarden, Maryland, pursuant to Resolution No. R-21-
2 97 and the Secretarial Concurrence with Modifications, designated a portion of the City of
3 Glenarden, attached hereto and incorporated by reference herein as Attachment “B”, as a
4 “designated neighborhood”, and it is the intent of the governing body of Prince George’s County
5 to include said portion of the City of Glenarden within the County’s Live Near Your Work
6 Boundary; and

7 WHEREAS, CR-71-1998, authorized the Prince George’s County Economic Development
8 Corporation to operate the Live Near Your Work Program, and it is the intent of the governing
9 body to discontinue the Prince George’s County Economic Development Corporation as the
10 operating agency; and

11 WHEREAS, the governing body of Prince George’s County authorizes the Redevelopment
12 Authority of Prince George’s County to operate the Live Near Your Work Program in its
13 jurisdiction and receive Live Near Your Work Grant funding from the Department contingent
14 upon approval by the Department.

15 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George’s
16 County, Maryland, that the expansion of the County’s Live Near Your Work Boundary to
17 include the areas shown on Attachments A and B is hereby approved and is added to the
18 boundaries previously approved pursuant to CR-71-1998.

19 BE IT FURTHER RESOLVED that the Redevelopment Authority of Prince George’s
20 County is hereby authorized to operate the County’s Live Near Your Work Project which shall
21 be made available to eligible employees purchasing homes pursuant to the Live Near Your Work
22 Project criteria.

23 BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to the Secretary
24 of Housing and Community Development of the State of Maryland.
