RESOLUTION

1 A RESOLUTION concerning

2 Maryland National Capital Park and Planning Commission

3 For the purpose of transferring certain appropriations and expenditures between certain programs
4 in the FY 2005-06 Operating Budget for the Recreation Fund.

5 WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2005-06 for
6 the Maryland-National Capital Park and Planning Commission was adopted by CB-29-2005; and

7 WHEREAS, under the provisions of Article 28, Annotated Code of Maryland, Section
8 2-118(a)(6), the budget may be amended by resolution by the respective County Councils on
9 their initiative or at the request of the Commission after receipt of recommendations from the
10 respective county Executives, and after public hearing upon reasonable notice to the public; and

11 WHEREAS, there is a need to provide funding for one recreation program, entitled Global
12 Development Services for Youth, Inc.; and

13 WHEREAS, in order to identify funding for Global Development Services for Youth, Inc.,
14 there is a need to decrease funding in the Recreation Fund for two programs entitled Capitol
15 Heights Boys & Girls Club and Forestville Basketball.

16 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
17 County, Maryland, that the following adjustments to the approved fiscal Year 2005-06
18 Maryland-National Capital Park and Planning Commission Operating Budget Recreation Fund
19 programs, as approved in CB-29-2005, are hereby made for the purposes set forth above:
