It is my pleasure to submit to you and the County Council the reappointment of Ms. Delores M. Stuckey, Ms. Yvonne V. Hefley, Ms. Darlene M. Neal, and Mr. Ike B. Udejiofor, Ph.D. to the Personnel Board for Prince George's County. The Personnel Board plays a vital role in the interpretation and adjudication of personnel law, County regulations and administrative policies all of which are critical to the fair and efficient operation of County government. Ms. Stuckey will continue to serve as Chair of the Personnel Board.

Ms. Stuckey, a resident of Bowie, is Chief of the Learning and Development Division at the Pension Benefit Guaranty Corporation (PBGC). She is responsible for all corporate-wide learning and development activities including executive coaching, mentoring, project management certification, management and leadership development, technical/occupation specific training, soft skills training, computer training and succession plan implementation. She is also responsible for managing all the training provided through the Small Agency Council (SAC) Training Program. Prior to PBGC, Ms. Stuckey worked at the Graduate School, U.S. Department of Agriculture in management and leadership development training. Ms. Stuckey is a graduate of Howard University with a Bachelor of Science degree in Psychology and George Washington University with a Master of Arts' degree in Education and Human Development.

Ms. Hefley, a resident of Oxon Hill, retired from the federal government after thirty (30) years of service. She serves as a Mediator for the Prince George's County Community Mediation Program, the District Court of Maryland (small claims cases), and the Montgomery County Circuit Court. Ms. Hefley is an experienced Equal Employment Opportunity (EEO) Counselor and Investigator for Title VII, Rehabilitation Act, Americans with Disabilities Act (ADA), Age Discrimination Employment Act (ADEA), and the Equal Pay Act (EPA). Ms. Hefley received the National Institutes of Health (NIH), Office for Research Services Award for support and dedication to the mission of Alternative Dispute Resolutions.

Ms. Neal, a resident of Temple Hills, is an experienced Human Resources Management professional. She has over two decades of experience in policy writing, retirement consultation, claims examination/adjudication, merit staffing, position classification and performance management. Ms. Neal retired from the United States Customs and Border Protection, Office of Human Resources where she managed the Work-Life Program Manager for ten (10) years. Ms. Neal also participated on Merit Promotion selection panels interviewing, rating and ranking candidates. She received her Bachelor of Science degree in Business Administration from Strayer University.

Mr. Udejiofor, a resident of Glenn Dale, has over twenty-five (25) year of well-rounded experience in the field of governmental human resources. He has in-depth experience in development, management, and interpretation of laws, rules, regulations, and processes applicable to classification, compensation, recruitment, staffing, and employer-employee relations. Mr. Udejiofor is the Senior, Human Resources Specialist with the United States Office of Personnel Management (OPM). His employment history also expands to the health care and university environments.
