**BACKGROUND INFORMATION/FISCAL IMPACT:**

This emergency bill provides for transfer of excess appropriations from the Greenbelt Middle School Renovation capital project to the Crossland High School Auditorium, Oxon Hill High School Replacement, Parking Lots/Driveways, Doswell Brooks Elementary School Renovation and the Systemic Replacements capital projects; and

The designation of this legislation as an emergency bill is necessary because of the County's immediate need to transfer appropriations funded by Qualified School Construction Bonds that must be expended by March 17, 2014 to certain educational facilities capital projects where existing appropriations are inadequate in order to ensure available funding for completion of the projects.
