#### BACKGROUND INFORMATION/FISCAL IMPACT:

This bill creates the Vacant Property Registry Program that applies to unmaintained vacant residential, commercial, and industrial dwellings and buildings located in the County. It provides for these dwellings and buildings to be placed on an unmaintained vacant dwellings and buildings registry list with a fine of \$1,000 for the designation. There are exemptions and a right to appeal. There is an annual reporting requirement.
