Council Bill 11 was presented by Council Member Dean and referred to the Planning, Zoning and Economic Development Committee (PZED).

<u>CB-8-2004 - AN ACT CONCERNING ADULT ENTERTAINMENT CLUBS</u> for the purpose of regulating the adult entertainment industry by establishing license requirements and penalties for violators and amending the provisions of the Code to clarify the use of the terms "public place" and "place open to the public."- <u>PRESENTED</u>

CR-12-2004 - A RESOLUTION CONCERNING REPEAL OF CHAPTER 81, 2003 LAWS
OF PRINCE GEORGE'S COUNTY, MARYLAND for the purpose of repealing the
enactment of Chapter 81, 2003 Laws of Prince George's County, Maryland. - <u>INTRODUCED</u>;
RULES SUSPENDED; ADOPTED

Council Resolution 12, as proposed by the Chairman by request of the County Executive and Council Members Knotts, Dernoga, Shapiro, and Dean, repeals Adult Entertainment Club regulations enacted by CB-86-2003. Council Resolution 12 was introduced by Council Members Knotts, Dernoga, Shapiro and Dean. Council Member Shapiro moved to suspend the Council Rules of Procedure to allow for the immediate adoption of Council Resolution 12; seconded by Council Member Exum. The motion carried by voice vote. Council Member Shapiro moved adoption of the Resolution; seconded by Council Member Dernoga. The motion carried 6-3 (Opposed: Council Members Exum, Harrington and Hendershot).

REQUESTS BY THE GENERAL PUBLIC TO ADDRESS THE COUNCIL

Reverend Keith Koch, United Baptist Church of New Carrollton, Maryland, addressed the Council regarding slot machines and gambling in Prince George's County, urging the Council to consider the effect on the poor and disenfranchised in their deliberations.

<u>POINT OF PERSONAL PRIVILEDGE</u> – Chairman Knotts spoke to the fiscal status of Dimensions Healthcare Systems, expressing Council's inability to fully support the requirements

outlined in the agreement between the County Executive and the Governor to provide the entity with Ten Million Dollars. He directed staff to schedule a meeting of the Council, Sitting as the Board of Health, to discuss the issue.
