**BACKGROUND INFORMATION/FISCAL IMPACT:**

This bill would establish a loan program, administered from the Economic Development Incentive (EDI) Fund, to support new and expanding child care centers and family child care homes. The bill provides eligibility standards and permissible uses of funds, requires the development of specific program administration procedures. Reporting on program activity will be part of the existing EDI Fund reporting.
