1 AN ACT concerning

2 Solid Waste Stream Analysis

3 For the purposes of amending provisions of the County Code relating to required ‘waste stream
4 analysis’[,];[and] amending the frequency from once every two (2) years to once every three (3)
5 years[,]; providing for a certain requirement; and [coincide] coinciding with timing of the Ten-
6 Year Solid Waste Plan.

7 BY repealing and reenacting with amendments:

8 SUBTITLE 21. REFUSE.

12 SECTION 1. BE IT ENACTED by the County Council of Prince George’s County,
13 Maryland, that Section 21-142 of the Prince George’s County Code be and the same hereby
14 repealed and reenacted with the following amendments:

16 DIVISION 4. SOLID WASTE RECYCLING

17 SUBDIVISION 1. COUNTY PROGRAM

18 **Sec. 21-142, Recycling program established; implementation; collection, marketing, and**

(j) The Director shall conduct a waste stream analysis of the waste stream to evaluate compliance with the requirements of this subdivision [every two (2) years.] every three (3) years with relevant data included within and shall submit the waste stream analysis to the County Council prior to [and coincide with] submitting or as part of any revisions to the Ten-Year Solid Waste Plan to be submitted to the Maryland Department of the Environment pursuant to Title 9, Subtitle 5, Environment Article, Annotated Code of Maryland.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
