**RESOLUTION**

1 A RESOLUTION concerning

2 State of Maryland Community Investment Tax Credit Program

3 For the purpose of approving the Hospice of the Chesapeake Foundation’s (HOC) project  
4 submitted to the Maryland Department of Housing and Community Development for  
5 participation in the Department’s Community Investment Tax Credit (CITC) Program.

6 WHEREAS, Section 6-401 through Section 6-406 of the Housing and Community  
7 Development Article, Annotated Code of Maryland, established the Neighborhood and  
8 Community Assistance Program to assist nonprofit organizations in carrying out approved  
9 projects in designated revitalization areas, to encourage businesses to invest in priority funding  
10 areas, and to strengthen public-private partnerships; and

11 WHEREAS, Section 6-404 of the Housing and Community Development Article,  
12 Annotated Code of Maryland, provides for the allocation of tax credits to business entities or  
13 individuals that contribute to approved projects of nonprofit organizations that provide services  
14 to priority funding areas; and

15 WHEREAS, Section 6-405(c) of the Housing and Community Development Article,  
16 Annotated Code of Maryland, provides that the Maryland Department of Housing and  
17 Community Development may not approve a proposal for participation in the Neighborhood and  
18 Community Assistance Program unless the proposal is approved by the governing body or  
19 authorized designee of each county, municipal corporation or political subdivision that includes  
20 any of the priority funding areas that benefits from the project; and

21 WHEREAS, Hospice of the Chesapeake Foundation, a nonprofit organization, has  
22 requested tax credits under the CITC Program for its Support for At-Risk Families Program; and

1           WHEREAS, the Hospice of the Chesapeake Foundation will use its tax credits to expand its  
2 services for uninsured and underinsured patients and community members in Prince George’s  
3 County; and

4           WHEREAS, the Hospice of the Chesapeake Foundation will apply to the Maryland  
5 Department of Housing and Community Development for approval of the Project and an  
6 allocation of tax credits in the amount of forty-five thousand dollars (\$45,000) for business  
7 entities that contribute to the Project pursuant to the Department’s Community Investment Tax  
8 Credit Program; and

9           WHEREAS, “Attachment A”, attached hereto and made part hereof, summarizes the  
10 Project; and

11           WHEREAS, the County Executive expresses approval of the Project.

12           NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
13 County, Maryland, that it hereby expresses approval of the Hospice of the Chesapeake  
14 Foundation Project, submitted to the Maryland Department of Housing and Community  
15 Development for participation in the Community Investment Tax Credit (CITC) Program, as set  
16 forth in Attachment A.

17           BE IT FURTHER RESOLVED that copies of this Resolution shall be sent by the Clerk of  
18 the Council to the County Executive, Hospice of the Chesapeake Foundation and the Secretary  
19 of the Maryland Department of Housing and Community Development.
