The Formation of an Agricultural District pursuant to the

Maryland Agricultural Land Preservation Foundation Program

For the purpose of recommending that the Maryland Agricultural Land Preservation Foundation approves the petition of K B Accokeek Land, LLC to establish an agricultural district.

WHEREAS, the district agreement, dated April 15, 2009, by Victor M. Kazanjian on behalf of K B Accokeek Land, LLC, requested the establishment of one (1) agricultural preservation district for approximately 123.55 acres (Tax Map 163/Grid B1/Parcel 8/Tax Account 05-0308015 and Tax Map 163/Grid B1/Parcel 8/Tax Account 05-0308007) located at 3539 Accokeek Road in Accokeek, Prince George's County, Maryland, as generally shown on the attached location maps: and

WHEREAS, the petition was referred to the Prince George's County Agricultural Preservation Advisory Board and the Prince George's County Planning Board for review and recommendation;

WHEREAS, the Prince George's County Agricultural Preservation Advisory Board found that the K B Accokeek Land LLC property met the qualifying criteria for productivity, size and location as set by the Maryland Agricultural Land Preservation Foundation, and recommended establishment of the agricultural district on March 27, 2009; and

WHEREAS, the Prince George's County Planning Board found that the establishment of the proposed agricultural district is compatible with existing and approved county plans and recommended approval of the petition and establishment of the district on May 14, 2009; and

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
