CB-047-2025 Building Code of Prince George's County

<u>CB-047-2025</u> (presented by: Chair Burroughs at the request of the former Acting County Executive)

Assigned to the Planning, Housing and Economic Development Committee (PHED)

AN ACT CONCERNING THE BUILDING CODE OF PRINCE GEORGE'S COUNTY for the purpose of updating the provisions of the Building Code of Prince George's County (the "County") to conform to the 2021 editions of the International Building Code, the International Mechanical Code, the International Energy Conservation Code, International Swimming Pool and Spa Code, International Existing Building Code, The National Fire Protection Association Life Safety Code The National Fire Protection Association Fire Code, The 2020 National Electrical Code, and the International Residential Code for One- and Two-Family Dwellings.

Legislative Summary:

CB-047-2025 was presented on May 6th 2025 and referred to the Planning, Housing, and Economic Development Committee (PHED). This bill would amend numerous Code Sections (noted below) to align Subtitle 4 with the 2021 editions of the International Code Council (ICC) and the National Fire Protection Association (NFPA) codes for the following:

- International Building Code
- International Energy Conservation Code
- International Existing Building Code
- International Mechanical Code
- International Residential Code
- International Swimming Pool and Spa Code
- National Fire Protection Code Association Life Safety Code
- National Fire Protection Association Fire Code

2020 National Electrical Code for:

- National Electrical Code
- International Residential Code for One- and Two-Family Dwellings

Current Law/Background:

Every three years, The Department of Permitting, Inspections, and Enforcement is required to review the International Code Council (ICC Codes) in accordance with Maryland State Code cycle for review and adoption in Prince George's County. Under current law, the County has adopted what was the most recent editions of the International Building Code, International Mechanical Code, International Energy Conservation Code, International Swimming Pool and Spa Code, International Existing Building Code, National Fire Protection Association Life Safety Code, National Fire Protection Association Fire Code, National Electrical Code, and International Residential Code for One- and Two-Family Dwellings. These codes have been updated, and this Bill amends the Prince George's County Subtitle 4 to conform to the 2021 editions of the International Building Code, International Mechanical Code, International Energy Conservation

Code, International Swimming Pool and Spa Code, International Existing Building Code, National Fire Protection Association Life Safety Code, National Fire Protection Association Fire Code, 2020 National Electrical Code, and International Residential Code for One- and Two-Family Dwellings.

Discussion/Policy Analysis:

Enacting CB-047-2025 would update the noted codes, including international building, energy conservation, and swimming pool and spa codes, as well as national fire protection codes, bringing them into conformity of the new standards. The expectation is that the public will benefit from the increased safety standards. This represents a health and safety measure for Prince George's County residents and visitors in terms of building construction, energy conservation for swimming pools and spas, and fire protection for certain dwellings.

Fiscal Impact:

• Direct Impact

Enactment of CB-047-2025 may result in a minimal negative direct fiscal impact in the form additional expenditures due to the increased staff training, additional enforcement, and marketing for staff, builders, and the public to implement, monitor and enforce the new updated codes.

• Indirect Impact

Enactment of CB-047-2025 could have a favorable indirect impact on the County by increasing the safety and quality of dwellings units on residents, increased energy efficiency (and longer-term cost savings) for swimming pools and spas, and increased safety for residents and visitors for fire protection. Negative indirect impacts could include increased costs for dwellings, rent, and certain services due to the higher standards in construction which could lead to higher development costs, which may be passed down to consumers.
