## TRANSPORTATION, HOUSING AND ENVIRONMENT COMMITTEE DATE: 9/29/98

CB-82-1998 legislation adopts the 1996 version of the BOCA National Building Code, to be used for construction in Prince George's County, correcting section numbers, removing obsolete terms and deleting references to the Mechanical and National Energy Conservation Codes inasmuch as they are adopted by the BOCA Code.

Staff gave an overview of the legislation, which was requested by the County Executive, and informed the Committee of comments which were received. The Legislative Officer reviewed CB-82 and prepared written comments addressing substantial and technical amendments. The Associate Director of the Permits and Review Division of the Department of Environment Resources, prepared written responses to each concern. These issues were discussed item by item at the Committee worksession.

A representative of the Plumbers Association was concerned with the issue of whether WSSC-licensed plumbers should be required to obtain a County permit for defined boiler work. The Office of Audits and Investigation has determined there should be no negative fiscal impact on the County as a result of enacting CB-68-1998.

CB-82 was held in committee on July 9, 1998 allowing staff an opportunity to meet with appropriate individuals to address outstanding issues that derived from the Legislative Officer's correspondence. Concern was raised regarding the proposed language, on page 6, lines 24-30 and page 7, line 20 to extend the length of permits. The Committee Members agreed to allow the added language to remain, since the Council's concerns deals more with shortened period for building permits associated with violation corrections and CB-82 applies to all other construction.

Language was added in CB-82 Draft 1, under Sec. 4-352, Fee Schedule, that authorizes the Director of the Department of Environmental Resources to develop a fee schedule in lieu of the fee schedule provided legislatively in the Building Code. The Committee Members agreed to delete the added language in CB-82 Draft 2 and retain the right to exercise that authority in concert with the County Executive.

Language was added in CB-82 Draft 2 on page 41, lines 11-13, "Permits for the installation of a natural gas fired boiler, water heater or pressure vessel shall be governed by the Plumbing and gas Fitting Regulations of the Washington Suburban Sanitary Commission," in an effort to rectify the concern of the Plumbers Association. Because additional corrections need to be made to Subtitle 2A, the committee requested that a separate bill be prepared for introduction at the October 6, 1998 Council Meeting.
