**LEGISLATIVE HISTORY**

Fiscal Policy & Government Operations Committee                      Date: 6/17/92

Committee Vote: Favorable as amended, 4-0 (In favor: Council Members MacKinnon, Bell, Del Giudice and Fletcher)

This resolution will amend the Collective Bargaining Agreement for Salary Schedule A for AFSCME Locals 2462 and 2735.

Highlights of the Agreement:

1. 8.5% COLA from 6/92-6/93.
2. No COLA in FY93.
3. No furlough in FY93 for more than two days or 16 hours. If taken on a holiday, 8 hours of annual leave will be granted.

Proposed Amendments:

1. On page 2, line 1, delete "14" and insert "28".
2. On page 2, line 16, insert the following new language:  

"BE IT FURTHER RESOLVED that the provisions of this Resolution shall supersede the provisions of CB-13-1992."
3. Salary Schedule A - Schedule of Pay Grades  

(A) On page 1, delete [June 14] and insert June 28.
4. On page 19 of the Salary Schedule, Article VIII, Annual Leave, delete "920" and insert "960".
5. Addendum to Memorandum of Understanding.

**BACKGROUND INFORMATION/FISCAL IMPACT**

**(Includes reason for proposal, as well as any unique statutory requirements)**

This is a companion legislation based on renegotiation of the Collective Bargaining Agreement between Prince George's County and Council 67 of the American Federation of State, County and Municipal Employees, AFL-CIO, and its affiliated Locals 2462 and 2735.
