


# **Aviation Program**

## Mission Statement

The Aviation Section provides critical airborne public safety services to the Citizens of Prince George's County. The Section provides a critical force multiplier to the Police Department and enhances the safety of patrol units.

Airborne public safety services are not limited to: observation of crimes and suspects, missing persons, vehicle pursuits, barricades, special events, reconnaissance, aerial photography, vehicle and property recovery, counterterrorism missions and community events.

In addition to its law enforcement mission, Aviation Section assets are used to survey environmental concerns, emergency weather conditions, building and site development surveys, firefighting, investigation, mapping, and live video data downlink to agencies including the County EOC.

Aviation Section assets are used to provide Counterterrorism operations and security measures from multiple airborne systems including rotary-wing and sUAS assets.

The Section serves multiple, local, State and Federal Agencies, including dozens of local towns and regions. The Section provides command and control platforms to Federal programs in the NCR to support Continuity of Government missions.

# **History**

- The Aviation section was started in August of 2000.
- A federal grant was given to the county for \$2,000,000 for aircraft and equipment.
   The County matched 10% for a total of \$2,200,000.
- In 1999, two new MD520N aircraft were purchased at a cost of \$968,000 each.
- \$264,000 was used to purchase mission and ground support equipment.
- In 2000 the initial maintenance budget was planned at \$580,000 per year, with planned steps to \$650,000 by 2003 and \$950,000 by 2010.
- The actual maintenance budget was \$500,000 from 2000 to 2015. It gradually increased to \$855,000 over the last 6 years.
- A third aircraft was planned for 2005 with an additional 2 crews allowing for partial 24 hour operations.
- A fourth aircraft was planned for 2010 with an additional 2 crews bringing the total manning to 8 crews for 4 aircraft allowing for uninterrupted coverage.



# History (continued)

- Winter Storm Jonas in 2016 lead to a prime example of the benefits of Aviation.
- A new aircraft was ordered in March 2017 for \$3,800,000 which included state of the art avionics and mission equipment.
- The manufacturer had unreasonable delays for over a year, so the new aircraft was cancelled.
- A plan was developed to purchase two prior owned aircraft and outfit them for the price of one new. Both aircraft were found in as new condition for \$975,000 each.
- The entire 2 for 1 aircraft acquisition cost the County \$4.15 million

## Performance

- The unit has flown over 45,000 flights
- The unit has flown over 23,000 accident and incident free flight hours
- Over 62,200 calls for service
- Over 2050 arrests, 70% being felony apprehensions
- Over 925 stolen vehicles have been recovered
- Over 440 LoJack vehicles, one of the highest recovery rates in the Country
- 265 firearms (47 with new camera)
- The unit has one of the most progressive training programs in the industry
- In 2007 our safety record lead to a 60% reduction in insurance costs. (\$73,000 per year)
- Aviation has received 7 International Airborne Public Safety Awards

### Costs

The section operates the most efficient single engine turbine engine rotorcraft for our mission. Our aircraft are \$365 (Direct Operating Cost) a flight hour to operate, contrasted to a Maryland State aircraft which cost \$7200 a flight hour.

The entire Aviation Program costs the County \$1.2 million a year

\$72,000 Facility lease

\$75,000 Fuel

\$8,000 Utilities

\$190,000 Insurance

\$855,000 Maintenance, safety, shop supplies

The cost of Aircraft ownership is \$38,000 a year per aircraft if not flown. The County owns all the aircraft outright.

# Summary

With four patrol aircraft in service, the Aviation Program could provide the citizens of Prince George's County, surrounding jurisdictions and agencies in the NCR, 24 hour Aviation services.

Two aircraft will be available at anytime allowing for special events and consistent patrols. With four aircraft in service now, patrols are now no longer limited for maintenance.

Airborne Public Safety is a critical force multiplier providing multifaceted mission support to daily operations. Developing Intra-County support to non-public safety Agencies will enhance the Section's mission capabilities and purpose. This will enable The Prince George's County Aviation Program to continue to thrive as the East Coast's most effective Airborne Public Safety Unit.
