**BILL**

1 AN ACT concerning

2 The Classification Plan for Prince George's County

3 For the purpose of adding and removing certain job classifications under Salary Schedule A of  
4 the collective bargaining agreement between the County and Council 67, American Federation of  
5 State, County and Municipal Employees (“AFSCME”), AFL-CIO, and its affiliated locals 2462,  
6 2735, 3389, and 1170.

7 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County  
8 Charter and Section 16-125(a) of the Prince George's County Code, has, in order to provide  
9 better governmental services, recommended to the County Council amendments to the  
10 Classification Plan of the County, with respect to the classes of work described in Section 1 of  
11 this Bill; now, therefore,

12 SECTION 1. BE IT ENACTED by the County Council of Prince George’s County,  
13 Maryland, that the Classification Plan for Prince George’s County be and the same is hereby  
14 amended as follows:
