WHEREAS	s, the City Council of the City of Glenarden, after a public hearing conducted on	
May 10, 2010, er	nacted Ordinance O-07-2010; and	
WHEREAS, this Ordinance (which is attached hereto and incorporated herein as		
Attachment A, and hereinafter referred to as "Ordinance O-07-2010") amended the City of		
Glenarden Code,	Chapter 130; and	
WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code authorizes		
municipalities within the MarylandWashington Metropolitan District to enact ordinances		
concerning residential parking and storage on land either zoned for residential or commercial use		
or adjacent to residential or commercial zones for the purpose of preserving, improving and		
protecting the general character and design of lands within the corporate limits of the		
municipality, provided that such ordinances impose stricter or additional limitations or		
restrictions than are otherwise imposed by the County zoning regulations; and		

WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that such ordinance shall not be effective until approved by the County Council of Prince George's County, sitting as the District Council; and

WHEREAS, the City of Glenarden, pursuant to Section 8-112.1 of Article 28 of the Maryland Annotated Code, has delivered a certified copy of Ordinance O-07-2010; and

WHEREAS, the District Council has determined that the Ordinance O-07-2010 imposes additional conditions upon residential storage than those currently imposed by Subtitle 27 of the Prince George's County Code (the "Zoning Ordinance").

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Ordinance O-07-2010 of the City of Glenarden, as represented in Attachment A to this Resolution, be and the same is hereby approved.
