BACKGROUND INFORMATION/FISCAL IMPACT:

Prince George's County, Maryland and the Fraternal Order of Police 112, Prince George's County Sheriffs Lodge Inc. (FOP 112), have completed labor negotiations on a two-year labor agreement covering Fiscal Years 2025 and 2026.
