| WHEREAS, i | t is informative to the citizens of the County to append to the County Code |
| the provisions of th | e County Charter and Laws relating to the Washington Suburban Transit |
| District; therefore | |
| SECTION 1. | BE IT ENACTED by the County Council of Prince George's County, |
| Maryland, that the | Prince George's County Code, 2007 Edition, is hereby compiled, codified, |
| adopted, and publis | hed: |
| (a) On and af | fter the effective date of this Act, the Prince George's County Code, 2007 |
| Edition, consisting | of Subtitles 1 through 23, Subtitles 24A through 26A, and Subtitles 28 |
| through 31, togethe | r with any additional Subtitles which may hereafter be enacted and any |

| 3 | (1) Conclusive evidence of the text of the Prince George's County Code and all |
| 4 | enactments dated on or before November 30, 2003. |

| 7 | Schedule of Legislation accompanying the Charter. |

| 10 | (C) All other County acts, ordinances, Code provisions, resolutions having the |

| 12 | (b) Supplements to the Prince George's County Code, 2007 Edition, shall be published at |
| 13 | least annually. |
| 14 | (c) The words "County Code" or "Code" shall be taken to mean the Prince George's |
| 15 | County Code, 2007 Edition, together with any current Supplement, unless the content clearly |
| 16 | requires otherwise. |
| 17 | (d) The 2007 Edition of the Code supersedes previous editions thereof. |
| 18 | SECTION 2. BE IT FURTHER ENACTED that the 2007 Edition of the Prince George's |
| 19 | County Code shall take effect on the effective date of this Act. The master copy of the 2007 |
| 20 | Edition of the Code shall be authenticated by the Legislative Officer and delivered as a public |
| 21 | record to the Clerk of the Council. The Clerk shall maintain that master copy together with any |
| 22 | Supplements thereto. A copy of the 2007 Edition of the Code shall be available at the Clerk of |
| 23 | the Council for public use during normal working hours. |
