RESOLUTION

1 A RESOLUTION concerning

2 The Washington Suburban Sanitary Commission Fiscal Years 2012-2017

3 Capital Improvement Program and Fiscal Year 2012 Capital Budget

4 for Prince George's County for Water and Sewerage

5 For the purpose of adopting with amendments the WSSC Fiscal Years 2012-2017 Capital

6 Improvement Program and Fiscal Year 2012 Capital Budget for Water and Sewerage.

7 WHEREAS, Section 23-304 of the Public Utilities Article, Annotated Code of Maryland,

8 requires the Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit on or

9 before October 1 of each year a Capital Improvement Program to the County Executive for Prince

10 George's County; and

11 WHEREAS, Section 23-304 of the Public Utilities Article requires the County Executive to

12 transmit said program together with comments, recommendations, and suggested amendments to

13 the Council; and

14 WHEREAS, this Capital Improvement Program must contain, at a minimum, major projects

15 as that term is defined in Section 23-301 of the Public Utilities Article , including water and

16 sewerage projects; and

17 WHEREAS, this WSSC Capital Improvement Program is part of the Adopted County

18 Comprehensive Ten Year Water and Sewerage Plan and contains projects to support water supply

19 and sewerage system development as proposed in the plan; and

20 WHEREAS, in accordance with Section 17-202 of the Public Utilities Article, the

21 Washington Suburban Sanitary Commission did timely submit to the County Executives of Prince

22 George's and Montgomery Counties the record of the public hearing held by the Commission on

1 the said Capital Improvement Program; and

2 WHEREAS, the WSSC has delivered its Capital Improvement Program to the County
3 Executive; and

4 WHEREAS, the County Executive has transmitted to the Council, the WSSC Capital
5 Improvement Program, together with such comments as were deemed appropriate; and

6 WHEREAS, Section 23-306 of the Public Utilities Article further provides that after notice,
7 the County Council shall approve, disapprove or modify the WSSC Capital Improvement Program
8 provided that the WSSC is afforded an opportunity to comment on suggested modifications; and

9 WHEREAS, the County Councils concurred with the recommended changes at the May 12,
10 2011 Bi-County Meeting; and

11 WHEREAS, all other requirements of Section 23-306 of the Public Utilities Article that
12 concern final action by the Council on the WSSC Capital Improvement Program for Water and
13 Sewerage have been met;

14 BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the
15 "Capital Improvement Program Fiscal Years 2012-2017," and the FY 2012 Capital Budget as
16 transmitted by the County Executive, is hereby adopted as amended by the attached Appendices.
