- MS. MCNEIL: Okay. Good morning,
- 3 everyone. I'm Maurene McNeil, and I'm the Zoning
- 4 Hearing Examiner in this matter.
- 5 We are here on July 16th, 2025,
- 6 for the second hearing on ERR-001-2025, request
- 7 of Hofmann Brothers, Inc., trading as Hofmann
- 8 Brothers Used Cars, to validate a permit issued
- 9 in error, permit number U14196.
- 10 It appears that we may have some
- 11 preliminary matters so I will allow -- I think,
- 12 Mr. Harrah, did I hear you saying something?
- 13 Would you like to go first and just state your
- 14 name for the record?
- MR. HARRAH: Okay. My name is
- 16 Thomas Harrah, and I live next door to the
- 17 property.
- MS. MCNEIL: Okay. So are you --
- 19 you're ready to proceed today?
- MR. HARRAH: Yes. I just want to
- 21 make some points that I got bits and pieces of
- 22 the first hearing on. And yes, I would like to
- 23 make some comments regarding the property.
- MS. MCNEIL: Okay. Well, wait one
- 25 second, Mr. Harrah. And so would counsel

- 2 MR. MARCUS: If it please the
- 3 tribunal, this is Bruce Marcus on behalf of the
- 4 applicant. And I am not on video because I am in
- 5 the midst of a bit of a medical problem.
- MS. MCNEIL: Okay.
- 7 MR. MARCUS: And we don't need to
- 8 have a revised horror show. I unfortunately have
- 9 a pretty profound bleeding problem.
- MS. MCNEIL: Okay.
- MR. MARCUS: And this is not --
- 12 this is not really good. I understand Mr. Harrah
- 13 has technical problems and would not be available
- 14 to appear on camera as well.
- So I would respectfully ask that

- 11 going to be one of those dates at 9:30.
- 12 And the prior hearing is still a
- 13 part of the record, but we will be mailing notice
- 14 to everyone that was supposed to receive notice.
- 15 And I'm sure the applicant has left the signs up,
- 16 so that tells folks how to get in touch with us
- 17 as well.
- 18 So Mr. Brown, if anybody has
- 19 anything -- do you have anything to say or to
- 20 add?
- 21 MR. BROWN: No. I'm available on
- 22 both August 18th and 19th, so that would be fine.
- MS. MCNEIL: Wonderful. Then, I
- 24 hope -- Mr. Harrah, that one will probably be
- 25 where you can come in person as well, if that's

- 1 easer for you. But I'll make a determination of
- 2 that, and it will be shown on the letter.
- 3 And Mr. Marcus, I hope you feel
- 4 better. For the record, I mean, Stan Brown would
- 5 say the same, we've known Mr. Marcus for many
- 6 years so even though we don't see him, we know
- 7 that's his voice.
- 8 So thank you all. I'm sorry we
- 9 couldn't go today. But you'll get a notice, and
- 10 we'll meet again in August.
