## PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE

Committee Vote, Favorable, 4-0, (In favor: Councilmembers Peters, Exum, Harrington and Knotts.)

This resolution will provide supplementary appropriations for grant programs in FY2004 in the amount of \$967,109. The additional appropriations will support new or expanded efforts of seven agencies.

The Office of the Sheriff received new federal funding in the amount of \$10,719 for the FBJ Joint Terrorism Task Force. Additionally, the Child Support Enforcement Program received an adjustment from the County in the amount of \$535,667.

The Police Department received \$55,835 in new funding for increased programming in the areas of Forensic Sciences, Domestic Violence Prevention and Arson.

The Office of Homeland Security received a reimbursement grant in the amount of \$2,246 for providing Emergency Medical Dispatch Training. Also, a grant in the amount of \$89,767 was received from the Maryland Emergency

Management Agency for the FY2003 State Homeland Security Grant Program - Phase II. These funds will be used to address the unique equipment, training, planning and exercise needs of first responders.

The Fire/EMS Department received \$17,180 in funding from the State of Maryland to provide training in the areas of hazardous materials preparedness and emergency preparedness.

The Circuit Court received increase appropriations in the amount of \$109,411 due to increased program income.

The Department of Social Services will receive increased appropriations in the amount of \$5,613 for Transitional Housing VI and \$5,557 for the Emergency Shelter Grant.

The Office of the State's Attorney received grant funding in the amount of \$135,114 for the Project Safe Neighborhood/Gun Crime Enforcement Program. These funds will be used for reducing and prosecuting gun violence in Prince George's County.

The Office of Law has reviewed the legislation and finds it to be in proper legislative form with no legal impediments to its adoption.

This resolution is retroactively effective to June 30, 2004.

There should not be any negative fiscal impact on the County as a result of adopting CR-68-2004.
