CR-113-2013 approves the terms and conditions of a Negotiated Payment in Lieu of Taxes Agreement (PILOT) by and between Prince George's County, Maryland and Woodland Townhomes LLLP, a Maryland limited liability limited partnership, to acquire a parcel of land located in District Heights, Maryland for the purpose of developing, constructing, owning and operating thereon a rental townhome community containing approximately 36 units and related facilities to provide housing primarily for low to moderate income families in Council District 6.
