**BILL**

1 AN ACT concerning

2 The Classification Plan for Prince George's County

3 For the purpose of adding class titles and grades for certain classes of work.

4 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County  
 5 Charter and Section 16-125(a) of Subtitle 16 of the Prince George's County Code, has, in order  
 6 to provide better governmental services, recommended to the County Council amendments to the  
 7 Classification Plan for Prince George's County which would add certain classes of work  
 8 comprising a new occupational series described within Section 1 of this Bill; now, therefore,

9 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 10 Maryland, that the Classification Plan for Prince George's County be and the same is hereby  
 11 amended as follows:
