The Jammu Kashmiri state of India was a previously autonomous sovereign state until August 5, 2019. On that day, the India government revoked parts of its Constitution, specifically Article 370 and 35A of its Annex. In doing so, the J&K state was infiltrated with India troops, subject to mandatory curfews and lockdowns, as well as an ethic cleansing of the Muslim population. As a result, much of the Muslim population were forced from their homes and those displaced person resettled here in Maryland and Prince George's County. August 5th is a day of remembrance for those who lost everything and had to rebuild.

This Bill authorizes the borrowing, administration and repayment of an amount not to exceed \$45,000,000 from the Maryland Water Infrastructure Financing Administration for the purpose of funding the County's obligations under its National Pollution Discharge Elimination System Municipal Separate Storm Sewer Discharge Permit ("MS4 Permit") to store or treat stormwater runoff in order to mitigate flooding, reduce pollutions loads, and achieve

impervious surface credits. Loan proceeds will be used for the retrofitting of approximately 425 impervious acres on multiple sites within the County. Multiple projects will be planned, designed, and constructed within the area subject to the MS4 Permit and will utilize a wide array of treatment options approved by the Maryland Department of the Environment including small rain gardens, large urban retrofit solutions involving suburban drain inlet modifications, pond retrofits, stream and shoreline restorations, green streets, high-flow media treatment devices, bio-swales and other green infrastructure. The mission of the Maryland Water Infrastructure Financing Administration is to provide financial assistance in the form of low interest rate loans and/or grant funding for clean water and drinking water capital projects across the State. The County has been the recipient of a 30-yr *MWIFA clean water loan for \$48,000,000 with an interest rate of 0.7%* ("SRF 1"), authorized by CB-076-2017. In addition, CB-076-2020 authorized an additional \$100,000,000 clean water loan for SRF 2 and SRF 3. This Bill will authorize borrowing up to \$45 million of subsidized long-term loans from MWIFA as follows: SRF 4: FFY 2020/SFY 2022 Water Infrastructure State Revolving Fund (WISRF) Intended Use Plan (IUP) Project Name: Urban Stormwater Retrofit Public-Private Partnership, PH 4 WQSRF Loan Amount: \$30,000,000 SRF 5: FFY 2021/SFY 2023 Water Infrastructure State Revolving Fund (WISRF) Intended Use Plan (IUP) Project Name: Urban Stormwater Retrofit Program Public-Private Partnership, PH 5 WOSRF Loan Amount: \$15,000,000.

The bill shall apply to all new single-family attached, single-family detached, two-family, two-over-two's and multi-family residential dwelling units constructed in Prince George's County on and after January 1, 2026 with certain exemptions and waivers. It provides for universally designed features. It provides for the potential waiver of certain requirements by the Director of the Department of Permitting, Inspections and Enforcement in certain instances. It makes amendments to applicable County Codes and provides that if any provisions conflict with the Federal Americans with Disabilities Act, the Federal Fair Housing Act, the Code of Maryland Regulations, the Maryland Accessibility Code, and any other applicable law, the Department of Permitting, Inspections and Enforcement shall apply the Maryland Accessibility Code, the Code of Maryland Regulations, the Federal Americans with Disabilities Act, the Federal Fair Housing Act and any other applicable law.
