For the purpose of am	ending the compensation of the County Executive and members of the
County Council.	
WHEREAS, Sec	tion 308 of the Charter of Prince George's County, Maryland, provides
that the compensation	of Councilmembers may be changed by an affirmative vote of not less that
two-thirds of the mem	bers of the Council; and
WHEREAS, Sec	tion 406 of the Charter of Prince George's County, Maryland, provides
that the compensation	of the County Executive may be changed by an affirmative vote of not less
than two-thirds of the	members of the
Council; and	
WHEREAS, any	increase in compensation which becomes law during one term of office
shall not become effect	ctive before the next term; and
WHEREAS, a Compensation Review Board was appointed by CR-57-2005 which made	
certain recommendation	ons regarding the compensation of the County Executive and County
Council; and	
WHEREAS, the members of the Compensation Review Board further recommended that	
the County Council sh	nould take action in light of certain relevant data which was not available
during the time allowed	ed for action by the Board; and
WHEREAS, it is	appropriate to modify the compensation for the County Executive and

those of comparable jurisdictions;

members of the County Council to reflect the duties of the offices and to bring them in line with

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's 2 County, Maryland, that the members of the County Council shall receive compensation for the 3 performance of their public duties under the Charter of \$89,000 per annum, beginning on the 4 first Monday in December, 2006, and adjusted annually thereafter on the first Monday in 5 December by a percentage equivalent to the percentage by which the Consumer Price Index for 6 the Washington Metropolitan area as of October 1 shall have changed from the preceding 7 October 1st. The compensation of the Chairman of the County Council shall be fixed at \$5,000 8 per annum in excess of the compensation of the salary of the other council members during such 9 person's term as Chairman, and the compensation of the Vice Chairman of the County Council 10 shall be fixed at \$2,500 per annum in excess of the compensation of the other council members during such person's term as Vice Chairman. 11 12 BE IT FURTHER RESOLVED that the County Executive shall receive compensation for 13 the performance of his pubic duties under the Charter of \$160,000 per annum, beginning on the 14 first Monday in December, 2006, and adjusted annually thereafter on the first Monday in 15 December by a percentage equivalent to the percentage by which the Consumer Price Index for 16 the Washington Metropolitan area as of October 1 shall have changed from the preceding 17 October 1st.
