LEGISLATIVE HISTORY

PLANNING AND ZONING COMMITTEE REPORT

DATE: 10/28/91

Committee Vote: Favorable as amended, 5-1 (In favor: Council Members Casula, Del Giudice, Fletcher, MacKinnon and Pemberton; in opposition: Council Member Mills).

Staff presented a proposed Draft 2, which would require the list of minor permits to be approved by the District Council upon the recommendation of the Planning Board and the Director of Department of Environmental Resources. This proposal is supported by the Planning Board and DER. Paul Rodbell spoke in support of the legislation.

There was concern by some committee members that the list of minor permits is not available in its final form, and it would be premature to adopt the legislation without this list. The Director of DER and the Planning Department agreed to transmit this list, in the form of a resolution, to the Council as soon as possible.

## PLANNING AND ZONING COMMITTEE REPORT

10/15/91

Held in Committee.

The Committee members were supplied with a list of permits that might be included on the list of "permits of a minor nature", but it was emphasized that this was only a sample list, and an official list would be agreed upon by the Directors of the Planning Department and DER following adoption of the legislation. The Planning Board supports the legislation, with an amendment requiring the Planning Board to approve the list of minor permit types. The Legislative Officer suggested that the criteria for determining what will be considered "minor" should be provided in the Code. The Municipal Association opposes the legislation, stating that "minor permits" should be defined prior to adoption of the legislation.

It was the consensus of the Committee that this authority should not be delegated to the Directors of the Planning Department and DER, or to the Planning Board. The bill was held pending further study.

## BACKGROUND INFORMATION/FISCAL IMPACT (Includes reason for proposal, as well as any unique statutory requirements)

The present law requires that permit applications be referred to the Planning Board for recommendation, and that any permit issued without that recommendation is illegal.

The Department of Environmental Resources and Maryland-National Capital Park and Planning Commission believe that certain permits of a minor nature should not be subject to this requirement.
