The December 2008 Cycle of Amendments to the 2008 Water and Sewer Plan contains three (3) applications requesting water and/or sewer category changes.

The Committee had no recommendations on CR–52-2009. The County Executive's recommendations on the three (3) category change applications were as follows:.

Application, 09/W-01 Mountain of Fire Miracle Ministries to be retained in a Category 5.

Application 09/P-01 Pranger Property Move from a Category 5 to 4 and Application 09/P-02 for Canterbury/Dhalwala Properties from a Category 5 to 4.

BACKGROUND INFORMATION/FISCAL IMPACT:

(Includes reason for proposal, as well as any unique statutory requirements)

The 2008 Water and Sewer Plan provides for three cycles of category change requests annually to amend the Plan. This Resolution represents the April 2009 Cycle of Amendments.

The 2008 Water and Sewer Plan was adopted by CR-91-2008, and amended by CR-17-2009. The April 2009 Cycle contains three (3) requests for a category change.

One (1) category change request is in the Western Branch sewershed and two (2) are in the Piscataway sewershed.

Environment Article, Title 9, Subtitle 5, of the Maryland Annotated Code, sets procedures for amendments and revisions to the Plan. At least 30 days prior to the public hearing on the amendments, the County Council must submit to the Washington Suburban Sanitary Commission and Maryland-National Capital Park and Planning Commission a copy of the resolution for their recommendations.
