RESOLUTION

1 A RESOLUTION concerning

2 The Revenue Authority of Prince George's County Fiscal Year

3 1999-2000 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Revenue Authority of
5 Prince George's County for Fiscal Years 2000-2005, prepared pursuant to the authority contained
6 in Subtitle 21A of the Prince George's County Code and providing comments on the proposed
7 Operating Budget of the Authority for Fiscal Year 1999-2000.

8 WHEREAS, Section 21A-119 of the Prince George's County Code provides that the
9 Revenue Authority of Prince George's County may propose one or more projects for inclusion in
10 the Authority's Capital Improvement Program and that the County Executive shall transmit to the
11 County Council for its approval by resolution or ordinance any such project approved by the
12 County Executive; and

13 WHEREAS, the County Executive has proposed for approval a single County-wide project
14 number TM900990 Revenue Enterprise Program, a copy of which is attached hereto; and

15 WHEREAS, Section 21A-118 of the Prince George's County Code provides that if the proposed
16 operating budget of the Authority includes any item to be funded from payments to be received
17 from the County that the anticipated receipts shall be identified for each item and a copy of the
18 proposed budget shall be transmitted by the Authority to the County Executive and the County
19 Council for their review and comment; and

20 WHEREAS, the Authority has forwarded its proposed operating budget to the County
21 Executive and the County Council for review and comment.

1 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince
2 George's County, Maryland, that subject to and in accordance with the authority of the Charter of
3 Prince George's County and pursuant to Subtitle 21A of the Prince George's County Code, the
4 Capital Improvement Program for Fiscal Years 2000-2005 of the Revenue Authority of Prince
5 George's County, as submitted by the County Executive to the County Council, a copy of which
6 is attached hereto and incorporated herein by reference as though it was set forth fully herein, is
7 hereby authorized, approved, and adopted.

8 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the
9 proposed Operating Budget, Fiscal Year 1999-2000, of the Revenue Authority of Prince
10 George's County and concurs with the proposed Operating Budget of the Revenue Authority.
