**LEGISLATIVE HISTORY**

FISCAL POLICY & GOVERNMENT OPERATIONS COMMITTEE                   DATE: 6/17/92

Committee Vote: Favorable as amended, 4-0 (In favor: Council Members MacKinnon, Bell, Del Giudice and Fletcher).

This resolution will amend the Salary Plan (Salary Schedule H) to reflect the labor agreement with Local #1619, IAFF, (Nonuniformed Civilian Unit).

Highlights of the settlement

- (1) 8% COLA - 4/92 - 6/93
- (2) All merit increases deferred until May 2, 1993.

Proposed amendments:

- (1) On page 2, line 6, after "1993" insert "a two percent (2%) increase in the base hourly rates effective June 13, 1993".
- (2) On page 11 of the Salary Schedule H, Schedule of Pay Grades, Section II, delete "(ten)" and insert "(eight)" and delete "May 1," and insert "March 7,".
- (3) Addendum to the Memorandum of Understanding.

**BACKGROUND INFORMATION/FISCAL IMPACT**

This is accompanying legislation based on negotiation of the Collective Bargaining Agreement between the County and Local #1619, International Association of Fire Fighters, (Nonuniformed Civilian Unit). This Salary Schedule H reflects wages and other economic items as reflected in the labor agreement by and between Prince George's County and IAFF Local No. 1619, (Nonuniformed Civilian Unit).

The estimated fiscal impact will be provided by the Office of Management and Budget.
