I hereby submit for the Council's consideration and confirmation the appointment of Angela Fair to the position of Director, Office of Management and Budget (OMB).

Ms. Fair is a seasoned public sector executive with more than twenty years of progressive leadership experience in budget oversight, policy development, strategic financial planning, and interagency collaboration. Over the course of her career, Angela Fair has managed operating budgets exceeding \$5 billion, overseen complex grant portfolios, and guided fiscal operations across public safety, health, and administrative agencies.

Angela Fair professional experience includes:

Providing executive direction and fiscal oversight as Deputy Director of the Fire/EMS Department, managing an annual operating budget of approximately \$310 million and significant grant portfolios.

Serving as Comptroller and Budget Manager for the Police Department, directing fiscal operations for a 1,700-member force and managing operating and grant budgets in excess of \$400 million; and

Prior experience as a Senior Budget Analyst in OMB and as Revenue and Utility Billing Manager for the City of Frisco, Texas, where she led revenue, billing, and forecasting operations during a period of rapid growth.

Academically, Ms. Fair holds a Master of Public Administration from the University of Arkansas at Little Rock and a Bachelor of Science in Accounting from the University of Arkansas at Pine Bluff, graduating with honors. She has also completed executive-level training, including the Senior Management Institute for Police (SMIP) at Boston University and the Andristine Robinson Leadership Institute.

Given her demonstrated record of fiscal stewardship, leadership, and commitment to public service, I am on behalf of the County Executive Madame Braveboy confident that Ms. Fair will provide exemplary leadership to the Office of Management and Budget and will be an asset to Prince George's County.
