RESOLUTION

1 A RESOLUTION concerning

2 The Creation of a Food Truck Hub at Streetcar 82 Brewing Company in the City of Hyattsville
 3 For the purpose of authorizing the creation of a Food Truck Hub at Streetcar 82 Brewing
 4 Company in the City of Hyattsville.

5 WHEREAS, Section 5-189.01 of the Prince George's County Code generally requires that a
 6 Food Truck Hub shall only be located on the open area or parking lot or public rights-of-way of
 7 the following: parks and recreational facilities under the operation and control of the Maryland-
 8 National Capital Park and Planning Commission, or areas within a one-quarter mile radius of the
 9 station entrance of any Metro and MARC stations; and

10 WHEREAS, the Food Truck Hub located at 4824 Rhode Island Avenue, Hyattsville,
 11 Maryland 20781(See attached Exhibit), is neither located in the parks and recreational facilities
 12 under the operation and control of the Maryland-National Capital Park and Planning
 13 Commission, nor areas within a one-quarter mile radius of the station entrance of any Metro and
 14 MARC stations; and

15 WHEREAS, the Streetcar 82 Brewing Company desires to create a Food Truck Hub in its
 16 location; and

17 WHEREAS, Section 5-189.01 authorizes that Food Truck Hubs not located at parks and
 18 recreational facilities under the operation and control of the Maryland-National Capital Park and
 19 Planning Commission or areas within a one-quarter mile radius of the station entrance of any
 20 Metro and MARC stations may be granted special authorization by resolution of the County
 21 Council; and

22 WHEREAS, the Streetcar 82 Brewing Company must still satisfy the requirements for the

1 Food Truck Hub License as enumerated in Section 5-189.03 of the County Code and remain
2 subject to approval by the Department of Permitting, Inspections, and Enforcement pursuant to
3 Section 5-189.01 of the County Code.

4 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
5 County, Maryland, that the County Council does hereby grant special authorization to the
6 Streetcar 82 Brewing Company in the City of Hyattsville to become a Food Truck Hub.

7 BE IT FURTHER RESOLVED that such authorization by the County Council is subject to
8 the Streetcar 82 Brewing Company satisfying the requirements for the Food Truck Hub License
9 as enumerated in Section 5-189.03 of the County Code and subject to approval by the
10 Department of Permitting, Inspections, and Enforcement pursuant to Section 5-189.01 of the
11 County Code.
