Committee Vote: Favorable with amendments, 9-0 (In favor: Council Members Bland, Campos, Dernoga, Dean, Exum, Harrison, Knotts, Olson and Turner)

Staff from the Economic Development Corporation explained the purpose of CR-69-2009. This resolution would endorse the County's application to the Maryland Department of Business and Economic Development to redesignate the Prince George's County Enterprise Zone and Focus Areas of the Enterprise Zone.

The Committee of the Whole reviewed the Enterprise Plan and amended the resolution to include the commercial areas of Camp Springs in the Enterprise Zone.

### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This resolution will endorse the County's application to the Maryland Department of Business and Economic Development to redesignate the Prince George's County Enterprise Zone and Focus Areas of the Enterprise Zone. The Enterprise Zone is an area designated by the Secretary of Business and Economic Development for the purpose of focusing State and local resources toward the encouragement of economic growth and employment in economically challenged areas of the State. The designation of the Prince George's County Enterprise Zone and Focus Areas of the Enterprise Zone will expire on December 15, 2009 unless an application for redesignation is approved by the Secretary of Business and Economic Development.
